Infant 10% of adult published fares. (No Agent commission)
Unaccompany minor **NO** child fare (only adult fare N-class above), not applicable on V, T & Q class.
- 3) Ticketing rule : 'Child' fare basis coloum (example NEE45/CH25 or NOW/CH25). 'Infant' fare basis coloum - Y/IN90.
ONE WAY fare basis must indicate not valid after 31 Dec 12.
- 4) Endorsement Box (D,B,H,K,L,M & N) : NONEND/RTE/RFD REF ISS OFFICE NOSHOW SGD150
Endorsement Box (Q,T & V) : NONEND/RTE/EXSIN VLD FLT DATE NOSHOW SGD150
Labour/Seamen/Student (D,B,H,K,L,M & N) : NONEND/RTE/RFD REF ISS OFFICE NOSHOW SGD150 (**LABOUR or SEAMEN or STUDENT**)
For Labour/Seamen/Student (Q,T & V) : NONEND/RTE/EXSIN VLD FLT DATE NOSHOW SGD150 (**LABOUR or SEAMEN or STUDENT**)
- 5) Tour Code : No indication of tour codes will be charged at full published fare.
- 6) Student/Labour/Seamen : Above fare may use for Student/Labour/Seamen. Ticket indicate baggage allowance 30Kgs.
Student fare for 30kgs entitlement only **applicable for 12-31 years old (PRC nationality).**
Fare Basis add in **SD for Student, DL for Labour, SC for Seamen.** Example (KOW/DL or KEE45/SD)
Using above fare for Student/Labour/Seamen, must attached photocopy of Student pass/ work permit/
Seamen book together with audit coupon to be file for airlines audit.
- 7) Flexibility : Combination method applicable on any classes under the **same routing** (RT + RT) divided by 2.
- 8) Restriction : No Open dated on return sector. **DO NOT USE CODE SHARE FLIGHT.**
- 9) Refund & Cancellation : Refund charges permitted at SGD80/ticket. No-show fee SGD150/ticket.
- 10) Add-on : Refer to Through Fare List.
- 11) Others : Above fares are quoted in Singapore Dollars and exclude all taxes.
